2025 marks the 42nd annual MVCMA Craft Fair, originally founded to provide an opportunity for Campground families to share unique, handcrafted items with the community. These artisan and crafted items have included many genres through the years, including: windchimes, stained glass, ceramics and pottery, lanterns, shell wreaths and art, holiday ornaments, hand knitted and crocheted items, jewelry, woodwork, original photography and painting and printed notecards, historical images, screen printed pieces, floral arrangements, jams and jellies, origami, home décor, baby gifts and more – impressive!

Participants MUST pre-register. Applications are now open, first to returning vendors and then to new prospective vendors, and we encourage early applications to reserve your table(s). Applications will close on July 12 or sooner if capacity is reached. Please return your completed form, with payment, as soon as possible to the MVCMA, in person at 80 Trinity Park or by mail to the address on the form.

IMPORTANT: please retain a copy of your receipt of payment. Vendors must be confirmed in advance. If you do not receive confirmation from me by email before the event of your paid registration, please contact MVCMA to confirm payment before July 12 so that you will have an assigned space at the show.

Additional details:

- **Tables will be set up by MVCMA and locations assigned to vendors. Vendors are not permitted to move their assigned table(s).**
- Tables are approximately 6-8 feet in length and **\$25 per table to reserve until June 1, 2025. Beginning June 1, \$30 per table.** 2 table limit per vendor.
- If you have an unconventional set-up and do not desire a MVCMA table, please email megdelisle33@gmail.com to confirm/approve your display and determine entry fee (one or two “tables”). At this time, no tents are permitted. Special considerations are made for physical accessibility needs as well as aesthetic requirements based on one’s art/craft.
- Vendors will bring table coverings on the day of the event.
- The event is “Rain or Shine.” Vendors are asked to please stay for the duration of the event.
- Refunds will not be given if the event is held.
